- Oct 1 2, 1943 13 km SOUTH OF SALERNO (GROMOLA) ITALY: Usual Regimental Personnel Section duties. Prepared for movement.
- Oct 3 10, 1943 NAPLES, ITALY: Personnel Section movement completed 3rd
 October 1943. Enlisted Men's payroll and Officers' pay
 vouchers for month of September 1943 paid. Total amount
 paid approximately \$75,000.00. Enlisted Men's Supplemental
 payroll, including miscellaneous full pay and partial payment vouchers completed and paid. Total amount paid approximately \$750.00. Machine Records Unit Rosters received,
 required corrections entered thereon and copies returned to
 9th MRU. Battle Casualty Report prepared listing one (1)
 EM returned to duty. (See CASUALTY ANNEX #1)
- Oct 11 15, 1943 NAPIES, ITALY: Usual Regimental Personnel Section duties, personnel correspondence, preparing and processing daily morning reports, G-1 daily and weekly reports, daily ration report, etc.
- Oct 16 20, 1943

 NAPLES, ITALY: Enlisted Men's payroll and Officers' pay vouchers for month of October, 1943 prepared, signatures obtained, and submitted to 6th Port Finance Officer.

 Usual Regimental Personnel Section duties, personnel correspondence, preparing and processing daily morning reports, G-1 daily and weekly reports, daily ration report.
- Oct 21 22, 1943

 NAPLES, ITALY: Usual Regimental Section Duties. Arrangements completed with replacement depot for officer replacements, six (6) Officers 2nd Lieutenants assigned and joined. 1st Lt. Henry E. Hill, Company "B", 540th Engineer Regiment and five (5) EM wounded in action during night enemy air attack and required Battle Casualty Report prepared and forwarded. (See CASUALTY ANNEX #1)
- Oct 22 31, 1943

 NAPIES, ITALY: Usual regimental personnel section duties, personnel correspondence, preparing and processing daily morning reports, G-1 daily and weekly reports, daily ration report. 286th Signal Detachment (1 Off and 54 EM) relieved from attached for duty, rations, quarters and administration (29 October 1943). Battle Casualty Report prepared listing lst Lt. Henry E. Hill and two (2) EM returned to duty (see 21-22 October 1943). (See CASUALTY ANNEX #1) One (1) EM listed as casualty.
 - Oct 31 Enlisted Men's October 1943 payroll amount to approximately \$70,000.00 paid.
